Moved to approve the Oct. 8, 2013 meeting minutes. Motion passed unanimously.

11.06.13.02 MOTION

Moved to approve the landscape management contract with Environmental Enhancements (EE) for the next three (3) years (2014, 2015, 2016) for the annual amount of \$70,202.76 with no increase over the current contract. Motion passed unanimously.

11.06.13.03 MOTION

Moved to ratify prior email-approved vote to approve a contract with NVM Contractors for snow-plowing services on an as-needed basis. Motion passed unanimously.

Tot Lot repair cost estimates are pending.

The no parking sign for the driveway between courts 6 and 7 will be installed next week.

Dave Atwood (Court 2) and Hal Vorhies (Court 3) have resigned as Court Reps. Replacements are being sought.

The Glen's 2014 calendar was distributed to Board members and the Management Agent.

Announcement of the winner of the Community Associations Institute's Association of the Year Award will be made in January. The Glen submitted an application emphasizing the communication channels in use – The Glen Echo, the Glen Alert system and the Yahoo group.

The Onsite Staff will lose medical insurance coverage through Cardinal Management beginning in January; but Cardinal Management's insurance broker is researching other options for them that would be financed in part by the Glen's current budget for this purpose. If there is nothing appropriate available, they will go through the new Health Insurance Marketplace at www.healthcare.gov.
