## Neighbors Need Our Help

A tragic house fire in early November in the nearby Columbia Forest neighborhood took the life of an Abingdon Elementary School third grader and her mother. Her father and sister survived, but the sister, who is a fifth grader at Abingdon, has been recovering from burns.

The Abingdon PTA has been working closely with the family to help in any way possible. If you would like to help, especially here at the holidays, there are two options:

# Glen Elects New Board For 2015

At the Glen's Annual Meeting on November 5, 2014, the Board of Directors gained three new members.

Jay Yianilos was re-elected to the Board for a term of three years by a vote of 35% of the voting interest (90.5% of the votes cast). Maynard Dixon was re-elected to the Board for a term of three years by a vote of 34% of the voting interest (87.5% of the votes cast). And Thora Stanwood was elected to the Board for a term of two years (fulfilling the final two years of Keith June's term) by a vote of 32% of the voting interest (83.2% of the votes cast).

In addition, the 2015 budget was approved by a vote of 36% of the voting interest (93.4% of the votes cast) and the minutes of the 2013 Annual Meeting were approved by a vote of 38% of the voting interest (96.3% of the votes cast).

Immediately following the Annual Meeting, the new Board held an organizational meeting to choose its new officers for 2015. They are:

## HOW TO PAY YOUR MONTHLY FEE



This month, Cardinal Management Group will be sending the 2015 payment coupon books to co-owners who are not signed up for direct debit of their accounts. If you do not receive your coupon booklet by 12/21/14, please contact Cardinal at 703-569-5797. Co-owners who choose this method simply mail their coupon and check to Cardinal each month.

Co-owners can also choose to authorize Cardinal to directly debit their bank accounts for the payment of monthly fees by filling out the form on page 4 of this newsletter and mailing it to Cardinal with a voided check. This seems to be the easiest method for most in the Glen. As noted on the form, the direct debit authorization will remain in effect, and will be adjusted automatically by Cardinal each year to reflect changed fee levels, until you provide written notification of its termination.

**IMPORTANT:** Some co-owners may have automatic bill arrangements with their banks (without directly debiting their account to Cardinal). In this case, you should update these arrangements to reflect the new fee levels.

Bill McShea, the long-time Court Rep in Court 11, has stepped down from his post. As a result, a new volunteer is needed to fill this important, vacant position.

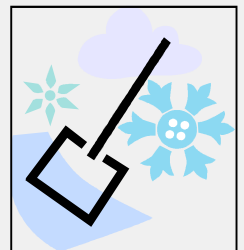

The CRG serves as the primary communication link between co-owners & residents and the Board of Directors. A Court Rep is both the eyes and ears of the court and serves an important role. Among the many duties of a court rep is to welcome all new residents to the court and provide them (both co-owners and renters) with our Glen Welcome Package.

## IT'S BEGINNING TO FEEL A LOT LIKE WINTER

We've already seen wet snow and freezing temperatures in Northern Virginia, although winter doesn't officially begin until December 21. But in the Glen, preparations for wintry weather began back in the summer.

Our on-site staff has already received an order of ice melt, which is stored in the maintenance shop along with the remaining bags from last winter. Ice melt products are used on sidewalks and walkways to residences. Plus, our new snow blade is ready to be attached to the tractor when needed to help clear sidewalks.



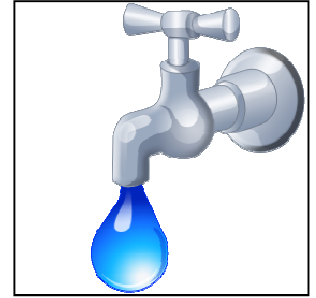
In September, the Board unanimously approved a proposal from NVM Contractors for snow plowing/sanding services on an as-needed basis for our courtyard parking lots.

The association provides limited snow removal from parking areas and sidewalks. Contractors and on-site staff begin work as soon as is reasonably possible after significant snow accumulations. The Board encourages residents to contribute to snow removal in the areas around their units and parking lots.

# CONGRATULATIONS TO COURT 13

At Fairlington Glen's Annual Meeting on Wednesday, November 5, Court 13 was awarded the annual Most Improved Water Usage Award.

Court 13's water usage in the four quarters ending August 2014 decreased 45.1% over the three previous years' average. The Board of Directors applauds this example of good citizenship within Fairlington Glen.



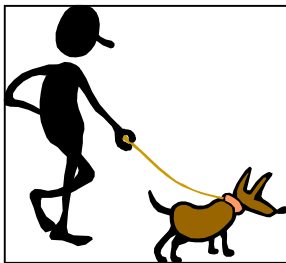
It should be noted that Court 13's water usage had been previously increasing due in large part to slow continuous leaks. Thanks to the residents of the court and the watchful eyes of our maintenance team of Nelson Ordonez and Maria Castro, the leaks were fixed.

There are many easy steps to reduce water usage, and here are a few:

1. When buying new washing machines, dishwashers, or toilets buy those with ENERGY STAR® ratings. These models use less water and save energy.
2. Run your dishwasher & washing machine only when filled to capacity.
3. Check your pipes and faucets for small leaks.
4. Turn off the tap while you shave or brush your teeth.

We appreciate anything you can do to help keep our water usage down.

## DOGS MUST BE ON LEASHES



Just a reminder, all pet owners must abide by Glen policy and Arlington County regulations concerning pets.

When taken outdoors, dogs must be kept on a leash at all times. Dogs are not permitted to run at large except at designated "off-leash" dog exercise areas located in Arlington County. The closest dog exercise area to the Glen is at Utah Field.

## PLEASE NOTE GLEN "WORKING HOURS"

Residents shall not make or permit any noises that will disturb or annoy the occupants of any units or do or permit anything to be done that will interfere with the rights, comfort, or convenience of other residents, particularly during nighttime and early morning hours from 10:00pm to 8:00am. Construction renovation by you or a hired contractor is prohibited generally from 6:00pm to 8:00am. Please make your contractor aware of our "working hours."

# THE GLEN 10 - 10 Q's & A's with Thora Stanwood

*Get to know your neighbors in the Glen each month through this feature we call the Glen 10. Please let us know if you'd like to nominate someone for an upcoming Glen 10 interview.*

**1. Where are you originally from?** - "Boston, MA. I lived there the first six months of my life and was then moved to Oak Ridge, TN. At age five, my family moved to the DC area, and I've lived here ever since, except for a brief time in Louisville, KY when I worked for the Kentucky Fried Chicken Corporation. And yes, I did meet the Colonel."

**2. How long have you lived in the Glen? And what model do you own?** - "I have lived in Court 2 for almost 30 years. I rented a Barcroft model for a number of years and then purchased it from the original owner. I really like this model as it has the bedroom and bathroom on the same level as the living/dining room and kitchen. It also has a large patio area."

**3. So when you first moved to Fairlington you were a renter. What made you want to buy and stay long term?** - "Location, location, location. Fairlington is so conveniently located to everything. I worked in southwest DC and could get there quickly by Metro. And all the stores I needed were close at hand. When the owner of my unit decided to sell, I realized I loved this neighborhood and did not want to move. So I bought the unit."

**4. What advice can you offer current renters about transitioning to co-owners and staying in our community?** "Once you move into Fairlington you realize what a great community it is. There are many activities in Fairlington itself, it is within walking distance of great stores and restaurants, and is so easily accessible to Shirlington and downtown DC. Fairlington is a great place to raise a family...and a dog. So, buy in and become a member of the Fairlington community."

**5. Congratulations on your election to the Board of Directors. As a Board member, what do you hope to accomplish?** "It takes a huge effort to keep the Glen (continued on page 8)"

financially sound, in good shape, and visually attractive. This can only be accomplished by resident teamwork, a strong management effort, and the hiring of capable contractors. Initially, I plan to work toward three goals...implementation of a strong court representative group, organization of a landscape committee so the chairman is not saddled with all of the work, and support of the contracting effort where I can use my background in contract execution and management.”

**6. You’re both a Board member and a Court Rep, but this isn’t your first time serving the community. How have you been involved as a volunteer in the past?** “As noted, when I first moved into the Glen in the late 1980’s I was a renter. Even so, I was intrigued by the effort needed to keep the neighborhood in good shape. Thus, I volunteered to be the rep for Court 2. At the time, the Court Reps comprised the Building & Grounds Committee (B&G), which met monthly to discuss issues affecting each court and the Glen as a whole. The chairmanship of B&G came open, and I volunteered to take up the reins. I served in that capacity for a few years. Then, the chairmanship of the landscape subcommittee became vacant. As I wanted to understand more about the Glen’s landscape projects, I chaired that subcommittee for a couple of years. It is so important for residents (owners and renters) to take time to participate in Glen functions. This is our home, and we should be proud of where we live. And we can only be proud if it is in good shape. Who keeps it in good shape? All of us.”

**7. Many folks in Fairlington will recognize you as a frequent walker with your friendly four-legged companion. Who is the bigger celebrity, you or your dog?** “Raymee is definitely the celebrity! He is a total social butterfly. I’ve lived here for 30 years and Raymee has been here for a mere year and a half, but more people know him than know me. You can’t miss him...he is the one with the tail that never stops wagging.”

**8. Your court hosted a terrific get together for Halloween. Is this an annual tradition, and if so how did it get started? Please tell us about your event.** “Our Halloween party is becoming a tradition. We set up tables, chairs, a fire pit, and lanterns where we could be visible for the kids and their parents as they came into our court. A lot of our neighbors brought out their candy and contributed food and beverages. We also raffled off a Halloween gift basket. Even Tina, our long-time postal carrier, came by. Tina is definitely an honorary Fairlington family member.”

**9. You recently retired. Congrats! Please tell us about your career. Where did you work and what did you do for a living?** “I’ve had two interesting careers...the first as a professional conference planner and the second as a contracting officer. I was a meeting planner for several trade associations and for the Kentucky Fried Chicken Corporation before joining the Department of the Treasury in 1995. I studied and trained to become a warranted contracting officer for the Office of the Comptroller of the Currency (OCC), where I remained until retirement in 2013. OCC is a little known bureau in Treasury with a huge responsibility, regulation of the national chartered banks. There are about 3,700 employees here and around the country, and I had the pleasure of working with about 500 of them by awarding and implementing contracts and by managing the OCC’s purchase card program.”

**10. What are your favorite aspects of retirement so far?** “My favorite thing is not having to get up at 5am anymore. My next favorite thing is a walk with Raymee to Starbucks. My retirement is still in the planning stage. I hope to visit family and friends from Massachusetts to Florida to California in the near future, and then some trips to Europe, Newfoundland, and beyond. Raymee and I would also like to visit children in local hospitals, but first one of us has to pass a test to be allowed in the front door. In the meantime, we will be walking around Fairlington. Please stop and say hi.”

## NEW SAFEWAY TO OPEN DECEMBER 5



After much anticipation from community residents, the new Safeway supermarket at 3526 King Street in Alexandria (next to the Bradlee Shopping Center) will celebrate its grand opening on Friday, December 5 at 8:00am.

The brand new 61,000 square foot store was built on the site of the previous Safeway, which opened in 1982 and closed in July of 2013. The following month, that facility was demolished and construction began on what is our new "lifestyle" Safeway.

The new facility will feature larger produce, deli, seafood, floral, and wine departments as well as include a Starbucks within the store.

There will be 228 parking spaces, of which 125 will be on ground level covered by the store. The supermarket is actually on the second floor of the building.
