If you are new to the community and need to obtain a recreation pass, fill out and email the form on page 5 of this newsletter (or use the fillable form under the documents tab on our website) to [glenpoolpass@gmail.com](mailto:glenpoolpass@gmail.com). Those needing a replacement pass should also fill out and submit the form along with a \$5 replacement fee. Glen recreation passes will be issued and delivered by our volunteer, Nan Lukmire. It may take up to two weeks for your pass to be processed and delivered.

**PRIVATE SWIM INSTRUCTION GUIDELINES** - The Glen Board of Directors has adopted new guidelines for the use of private swim instructors at the Glen pool for 2016. Fairlington Glen members' private arrangements with non-member swim instructors are allowed, provided that:

- (1) the instructor is an eligible guest of the member employing him/her, which requires, among other things, that the employing member be present in person while his/her guest is at the pool, i.e., no babysitting, delegation of role to juvenile family members, etc.;
- (2) the instructors observe the same rules governing pool usage that apply to members, in particular the usage of lap lanes;
- (3) the instruction does not take place on weekends; and
- (4) the following provisions on liability are observed: (a) all private instructors must provide proof of general liability insurance coverage with limits of not less than \$1,000,000 per occurrence and \$2,000,000 annual aggregate for the full benefit of Fairlington Glen ("the Glen"), with the Glen named as an additional insured under the terms of such coverage, and (b) private instructors must execute a hold-harmless agreement in favor of the Glen, including indemnification and defense provisions.

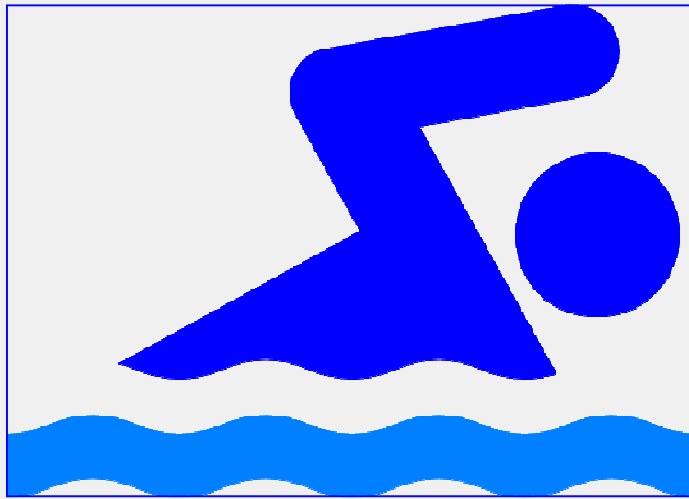

**FAIRLINGTON GLEN POOL PARTY RULES** - Recreation pass holders may request a non-private party. Requests for parties should be directed to the pool committee and the pool manager. There is a limit of one party per day. The pool calendar will be posted at the pool. A non-refundable charge of \$25 will be assessed. The requester/recreation pass holder is responsible for abiding by all pool rules and also the following party rules:

- The party is limited to 2 hours in duration. / Set-up is allowed one hour prior to the party
- Food is allowed in the canopy area only; party will receive priority use of this space.
- The party is limited to 25 persons (this includes children).
- Only children under the age of 6 are permitted in the baby pool.
- The pool remains open for ALL Glen residents during the duration of the party.
- All party trash must be removed from the pool area immediately after the party and taken home with the requester/recreation pass holder.
- Resident must speak with the pool guard/operator the morning of their party and provide the guard/operator with an emergency contact number (phone works best - pool internet can be intermittent) in case of a pool emergency/closing. Occasionally, the pool may need to close due to unforeseen circumstances such as stormy weather, power outages, or accidents in the pool - guards will notify you.

Checks should be made out to FAIRLINGTON GLEN with "pool party" written on the memo line. Drop the check at 4316 S. 35th Street (Court 16).

# RECREATION PASSES



Thinking about using our beautiful and recently resurfaced basketball and tennis courts? Dreaming of summer fun at the Fairlington Glen pool? Then get a Glen recreation pass and get ready for fun! You don't need to reapply for a pass each year UNLESS you have lost a pass (in which case there is a \$5 charge for each replacement pass—checks payable to FAIRLINGTON GLEN) or if a family member has turned 12 in the last year. You can choose to get a family pass, which can be used by all family members, or have passes issued in individual names (for those ages 12 and over).

To obtain a recreation pass, please print this page, fill it out, sign it, and email it to our rec pass volunteer at [glenpoolpass@gmail.com](mailto:glenpoolpass@gmail.com). It may take up to two weeks for the processing of applications. Your pass will be delivered to your home.

Passes are delivered in a plain white envelope. The code for the tennis court is on the bottom right of the pass. These laminated passes are good for as long as you live in the Glen. If you are a co-owner and choose to move out and rent your home, you can still come to the pool. We'll also provide your renters a pass if requested, but that doesn't affect your ability as a co-owner to enjoy our amenities, too.

# Trash Talk Proves To Be Very Interesting

On Monday, May 23, David Dunn, the president of Capitol Services, Inc., our trash and recycling contractor, spoke to the community at the quarterly meeting of the Court Representatives Group (CRG). A small crowd of Court Reps, Board members, and residents were treated to some interesting information about our garbage.

First, Dunn started his business in 1983 with his brother, and Capitol has been picking up trash throughout all of Fairlington for a long time. In fact, several of Dunn's employees have worked for the company for many years. In the Glen, we pay approximately \$5,500 a month for our 6-day-a-week trash pick up, weekly recycling pick up, and monthly bulk trash pick up.

"We want to keep it nice and clean," said Dunn. "We really try to take care of you guys."

Secondly, the most interesting note from this meeting is that none of the trash collected in Fairlington is sent to a landfill. Our household trash is picked up and delivered to Covanta at 5301 Eisenhower Avenue in Alexandria. Covanta is an energy from waste facility, and our garbage is burned and turned into methane gas for electricity.

Dunn noted that the garbage is dumped and inspected at Covanta to make sure there is no construction material (drywall and bricks especially) or large trees/landscape debris in our trash. It is all pushed into a pit and placed into an incinerator for burning.

What becomes of our bulk trash that's collected once a month? Large metals are taken to nearby recycling facilities and everything else is burned at Covanta.

As for our weekly recycling, Dunn said that Capitol puts out 80 blue & gray buckets per week in the Glen to collect glass, plastic, and aluminum. Soon he will add a yellow bucket for newspapers and mixed papers only. All cardboard should continue to be placed on the ground next to the containers.



He asked all residents to please rinse out food containers before recycling because contamination from food means the item cannot be recycled. And be sure to look on plastic containers for the recycling symbol to ensure it can be recycled. Anything that the recycling center will not take goes to Covanta to be burned. "Just be assured nothing is going to landfills up here (Northern Virginia) anymore," said Dunn.

It's ok to place plastics, glass, and aluminum in a plastic bag and then into the blue/gray bins.

Styrofoam food containers can be recycled, but the Styrofoam popcorn or packing peanuts found in packages is not recyclable.

Court Rep volunteers serve as the eyes and ears of their court by reporting maintenance issues and welcoming new residents. Court Reps are encouraged to maintain a court directory, including email addresses, so that important information can be shared with residents from time to time. Court reps should also familiarize themselves with the Glen's Handbook and By-laws, both of which are posted on our website.

## Variance Requests - An Important Reminder



If you are planning to submit a variance request, please remember that three copies of the application and your additional documents or drawings are necessary. All three copies must be signed and notarized.

Completed variance request applications are submitted to Greg Lukmire, our variance coordinator. After Greg has a chance to review your request, it gets turned over to the Board for a vote. Please keep in mind that it may take 45 days for the entire process to be completed.

# Democratic Primary Is June 14



There will be a Democratic Primary for the Arlington County Board on Tuesday, June 14. Polls will be open from 6:00am to 7:00pm so that registered voters can cast their vote. Glen residents vote at the Fairlington Community Center.

You are reminded to bring an approved photo ID to vote. In Virginia, voters are not registered with political parties. Therefore, regardless of the party you affiliate with, you may vote in this primary.

Absentee voting by mail continues. Applications must be received at the Voter Registrations & Elections office by June 7 at 5pm.

In-person absentee voting runs until June 11 at 5pm. Hours are 8:00am to 5:00 Monday thru Friday and 8:30am to 5:00pm on Saturday, June 11. In-person absentee voting is done at the Voter Registrations & Elections Office at the Courthouse Plaza, 2100 Clarendon Blvd., Suite 320 in Arlington.

# LANDSCAPING IN COMMON AREAS

## **Modification Of Front And Side Beds (Blanket Variance)**

Co-owners may plant annual or perennial plants (excluding vegetables, fruits, mint, bamboo, and ivy) within common original front or side beds, provided the borders of the bed are not extended. However, the Board reserves the right to request the removal of any plants that are not maintained according to the landscape contractor's standards. In addition, if the ground immediately adjacent to the rear of a unit's fence has a significant slope, a ground cover may be planted in this area in order to reduce erosion so long as the ground cover remains clear of the fence.



Mulch must correspond in both color and texture to that used by the Glen's landscape contractor. Non-plant additions to front and side beds must be inconspicuous.

## **Other Plantings**

Any owner wishing to plant flowers, trees, or shrubs other than those mentioned above inside or outside of existing beds MUST submit a variance request. Once a variance has been granted, it is the co-owner's responsibility to maintain the plantings and bed (e.g. pruning, weeding). If the variance is not properly maintained, the Board may revoke the variance and have the bed returned to its original state at the co-owner's expense. Common area trees are maintained by the Glen. Please do not try to prune them yourself. And please help protect them by not allowing children to use them for recreation by climbing on them or attaching swings to them.

## **Containers/Hanging Plants (Blanket Variance)**

Co-owners may plant flowers or small shrubs in containers, such as tubs, pots, or hanging baskets provided that:

- The container does not obstruct front access in or out of the units.
- The planting is carefully maintained, with regular attention to watering, etc., and is not permitted to become unsightly.
- Any hanging plant in the rear of a unit is below the fence line, except for those hanging from rear canopies.
- Planters are not hooked over the top of a fence.
- Pots, trellises, or any other structures are not placed in any common plant beds

## **Hose Holders**

Hose holders should be unobtrusive, mounted behind plantings if possible, and anchored with a masonry anchor. Repairs to damage to the brick or mortar will be the homeowner's responsibility.

## **Vines**

No vines or plants with vine-like qualities (Virginia Creeper, Boston Ivy, English Ivy, Euonymus, Wisteria, Climbing Hydrangea, or Trumpet Vines) will be allowed on building facades and fences.

## **Plant Bed Edging**

In general, there is to be no edging around the plant beds other than that provided by the Glen's landscape contractor. The contractor cuts the plant beds to delineate them from the lawn area and to prevent damage to flowers by mowers. The Board realizes that edging in the rear, side, and fronts of units may be required in some cases, such as when the co-owner wants to build up the plant bed with a better quality soil or when a retainer is needed on a sloping area. In these cases, the co-owner MUST obtain a variance and use the following edging materials:

- Red brick (without holes) of the same color & character as that of the Fairlington Glen buildings.
- 4" x 4" pressure treated landscaping timbers left in a natural state.
- Natural stone.

All edging must be maintained in good repair and must not interfere with lawn maintenance. Wire and plastic are not permitted.

## **Landscape Lights (Blanket Variance)**

Installation of low-intensity, ground level landscape lights within planting beds adjacent to a co-owner's unit is allowed under the following guidelines:



- Up to six low intensity lights, each not exceeding a height of 26 inches may be installed at least 18 inches apart from one another.
  - Lighting fixtures must be unobtrusive as to color of finish and style.
  - Lighting may not be directed or shine off the bed in which it is installed. In particular, care must be taken in arranging the angle of a light so as not to disturb neighbors.
  - Lighting fixtures illuminating beds must be focused downward.
  - Lighting installations are restricted to not more than 200 watts total with a maximum wattage per fixture of 50 watts.
- Colored lighting or any off-norm color is allowed only as part of seasonal holiday decorations.

## **Final Landscape Notes**

Changes to the size or shape of an existing front or side bed, or construction of a new bed, requires a variance. Installation of edging materials around an existing bed requires a variance. Installation of a watering system in an existing bed requires a variance. If you are not sure whether a variance is required for landscaping work, please speak with a member of the Landscape Committee, the Board, or the Variance Coordinator in advance of doing any work.
