
Fairlington Glen Resource Guide: “Did You Know? 2007” Attached

MESSAGE FROM PRESIDENT (CONTINUED)



Winter finally caught up with us in February. Day after day of cold, and then a typical wet Washington snow storm midday on a Tuesday. Despite a mixup that led to a late start, our plowing contractor was able to get to most parking lots before the end of the day. Unfortunately, that plowing was not everything for which we might have hoped. The real problem, however, came that night when frigid temperatures turned all the wet snow to thick white ice. At that point, there was nothing to do but wait for warmer air almost a week later. Then, of course, another storm hit this past Sunday morning. All the predictions called for freezing rain and sleet. Trying to get ahead of that kind of problem, our crew spread de-icer on all the sidewalks that morning. Late in the morning thick snow started falling, eventually leaving us with four or five inches of the stuff. Another case of best laid plans gone awry. I appreciate the efforts of all our Glen neighbors who cleared the walks in their courts that afternoon because by the time the snow came it was too late to recruit shovelers until Monday morning. We can hope to dodge more snow as we trudge toward spring. That would be great if it happens. But since we can't control the weather, all I can pledge is that the Glen will continue to do its best to meet the challenges as they come.

SEWER STUDY IN PROCESS



Planning is well underway for the various engineering studies that Restoration Engineering, Inc. (REI) will conduct this spring of sanitary sewers, storm sewers, and site drainage issues. Thanks to all of you in low units who are participating by providing access to the internal point in your basement from which the sewer lateral exits the building. We will be in touch with those of you who need to take steps to make access available. This will enable you to participate by having a videotape made of your line. Because the possibility of a sewage backup exists in such units, we encourage you to take advantage of the opportunity offered by this study.

The sanitary sewer study, which will provide us with a more detailed map of the Glen's sewer lines than we have ever had before, will also enable us to integrate our landscaping plans with the need to keep roots out of our aging sewer lines.
