

PAINTING OF COURTS 5-8

We are moving to a new painting contractor this year for Courts 5, 6, 7, and 8. The company is Middledorf Property Services, Inc., a family-owned and managed company from Maryland. Middledorf comes highly recommended by the Meadows, who used them last year. They will be using an articulated lift to do work on the roofs, i.e. the valleys where two parts of the roof meet, the flashings around the chimneys, and the high dormers. They will be painting all exterior wood surfaces and replacing broken and rotted wood in areas such as porch columns and porch ceilings. If you live in Courts 5, 6, 7, or 8 (the courts along King St.), and believe there is a wood problem, please call the maintenance office, your court representative, or Jim Hewitt to make sure that the problem is included on our list. Jim Hewitt, a Co-Owner and contractor himself, will be the Glen's representative interacting with Middledorf this year. Please call him at 703-379-1887 if you have any concerns with the painting project as it proceeds. You will be notified before work begins on your unit.


BUDGETS FOR 2006 AND 2007



Fairlington Glen, along with the rest of Arlington County, is facing steeply increasing water and sewer rates as a result of a \$410 million upgrade to the sewage treatment plant on Glebe Road to comply with State mandates. You may have seen a recent article on this subject in the Washington Post (April 17). The increases started showing up in 2004 and we should have been aware of them. Unfortunately, neither the 2005 nor the 2006 Glen budgets provided for these increases. As a result, our 2005 water and sewer bills were \$28,000 over budget, and our 2006 bills will be even more over budget.

We are not talking small numbers. The cost in 2005 was \$130,000, or \$369 per unit on average, while the monthly condo fee for an inside Clarendon was \$247, so about 1 1/2 months of your total annual condo fee went for water and sewer. While there is nothing we can do to change water and sewer rates, which are now projected to increase by about 15% a year for the next five to ten years, we need to provide for these increases in our future budgets.

This discovery of the projected future for water and sewer bills presents a challenge for 2007 budget preparation. Drafting of the 2007 budget begins next month and the Finance Committee welcomes Co-Owners or residents who would like to participate in that process. HELP ELIMINATE BACKYARD THREAT


Mosquito breeding season is upon us. Remember to eliminate sources of standing water in your back patio. Even small pools of water (as small as a bottle cap) can provide breeding ground for the tiger mosquito. This particular type of mosquito breeds in areas where most other mosquitoes don't—in tire treads, cans, flowerpots, sandbox toys, and even wrinkles in plastic bags. (Source: Washington Post May 2, 2006) Remember, water can collect at the base of your outside drain pipes. If you have an extender, you may want to check for standing water. Also, DEET sprays will repel mosquitoes, but not kill them.

BOARD MEETING INFORMATION

At the Board meeting on May 2, a number of decisions were reached. Among these were:

- changes to our telephone system which we expect to both improve our communications and save money
- change to a new painting contractor who has come highly recommended by Fairlington Meadows
- establish an investment policy which will insure we maximize our investment returns within a framework which will protect our assets
- plantings, tree and shrub maintenance to beautify our grounds after a tough winter.

Once again, we had a discussion of strategic planning on our agenda and found ourselves without time to begin this important topic. Instead, Board member Alison Burns Trimble will host a dinner meeting on May 10. We hope this unstructured meeting will give us a chance to talk about how to assess where the Glen should be going over the next several years as well as to lay the groundwork for further planning for years to come. =====




FAIRLINGTON FINS SWIM PROGRAM 2006
