Nelson and María are participating in the spring preparation for pool opening. They are an important part of the sanitary sewer study being conducted by our engineering consultant, as they both snake and videotape the laterals, working with the engineer. Such snaking and camera work will also be part of the storm sewer study later this month, working as a team with the engineering consultant.

The Board values their contributions and applauds the initiative they have shown. We plan to use their considerable skills as we move forward over the next few months. In particular, the Maintenance Committee, Management Agent, and Board will work with staff to develop and publish a maintenance schedule so you can see when various activities are planned during the year.

#### Pool Buildings Proposal Begins to Take Shape



The Pool Buildings/Maintenance Office/Workshop Committee has met four times to discuss the current condition of the pool buildings, and their future, taking into account the needs of the community and maintenance crew. The group has decided to develop a long-term, phased plan for the buildings and hopes to present a rough plan to the Glen Board by July. The next step, with the board's initial approval, would be to hire an architect to further develop the plan.

We are looking at buildings that are now quite old and a structure over the pool entrance that is rotted. Part of the committee's task is to determine how urgently changes need to be made to various components.

The committee has decided that the obvious immediate need is the building that houses the pool bathrooms. We are currently discussing whether upgrades that include enclosing and winterizing the buildings are desirable. The second priority is an office/workspace for the Glen crew. We have visited the Meadows building, which once looked like our own, and determined what we like/dislike about the design of their modifications.

Currently, we are leaning toward expanding the building to enclose the fenced-in space that presently houses maintenance equipment, and upgrading the office space, lifeguard room and pump room. At some point in the future, the committee would like to see the entrance to the pool change to the end of the sidewalk coming in from  $36^{th}$  St. and enclosing the current entrance with a building that would house a community/meeting room for residents. The latter idea would be far into the future of a phased plan.

The committee is interested in hearing your opinion of our plans so far. #### **Landscape News and Notes**







On May 3rd, the Board approved three landscaping related proposals from our new arborist (Thrive), our land-scaper (Environmental Enhancements) and the Davey Tree Company. Thrive will prune trees which have been damaged in the recent wind storms and need removing/pruning/reinforcing. Environmental Enhancements will provide requested new plantings to replace dead/dying plantings and improve the appearance of the Glen's land-scaping. The Board also approved a bid from Davey Tree to move the 25 foot tall Zelkova Elm in Court 10 approximately 50 feet from its current location. This action is necessary to try and save a tree which otherwise would need to be cut down as a result of an upcoming lengthy sanitary sewer replacement (the sewer line runs directly beneath the trees' current location). With the proper after care, there is a very good chance of this healthy and mature tree surviving.

We want to thank everyone who used the landscaping request form provided in the February Glen Echo. Using this form is the most efficient way for the Landscaping Committee to respond to needs identified by co-owners near their units. We also want to remind people that if the have a new planting near or in front of their unit, to water it sufficiently throughout the summer to make sure it survives its critical first year. We encourage anyone who wants to supplement the beds in front of their units with their own plantings to do so. There will be a second round of tree work and plantings in the fall, and a notice and new request form will be published in the June Glen Echo, which will be followed by another walkthrough in August to review those requests.
