News From The Board



The Fairlington Glen Board of Directors held their monthly meeting on Tuesday, March 12, 2019. Here are some of the notes from that meeting.

ENVIRONMENTAL UPDATE

APPROVED

The Board approved a contract with James R. Walls Contracting Company, Inc. in the amount of \$7,840 for chimney repairs at 4119 S. 36th Street (Court 4).

The Board approved a contract with NVM Paving and Concrete in the amount of \$4,500 for sidewalk repairs throughout the Glen.

The Board approved a \$1,000 bonus for onsite staffer Maria Castro to commemorate her 20th anniversary as a Glen employee.

The next monthly Board meeting will be on Tuesday, April 9, 2019 at 6:30pm at the Fairlington Community Center, located at 3308 S. Stafford Street.

CRG To Meet; Court 8 Rep Still Needed

The next quarterly meeting of the Court Representatives Group (CRG) is set for Monday, April 29 at 7:00pm at the Fairlington Community Center. All court reps and alternates are encouraged to attend, as are those interested in becoming a court rep.

Fairlington Glen's CRG serves as the primary communication link between co-owners, residents, and the Board. The CRG serves as a forum for interchange and communication at the local court level and deals with tasks that are best performed on a court-by-court basis. The CRG is chaired by a co-owner and is comprised of a representative and/or alternate (co-owners or renters) from each of the 16 courts.


Among the CRG's functions are to welcome new residents to the court, maintain a contact list with email addresses for your court, transmit information from the Board to the court's residents and transmit suggestions from the court's residents to the Board, check for rules violations, inform residents of and remind them of Glen policies, monitor the physical upkeep of the court and report maintenance problems, and notify the management agent of items requiring immediate action.

Webmaster Ron Patterson Retires

As mentioned on page 1 of this issue, Fairlington Mews coowner Ron Patterson, who served as the Glen's webmaster for 20 years, has retired. You may have lived here for many years and never known who was maintaining our site, but now you'll know the full scoop.

Ron served on the committee which helped to secure historic designation for Fairlington from the Virginia Landmark Register in 1998 and the National Register of Historic Places (by the U.S. Department of the Interior) in 1999. In addition, he was the first president of the Fairlington Historical Society and was honored with a plaque from the Fairlington Historical Society Board of Trustees. Ron also served as the Mews treasurer and co-editor of the Mews newsletter.

He designed, launched, and managed the South Fairlington websites beginning on June 4, 1999. North Fairlington (Fairlington Villages) had its own site.

Ron said he learned basic web design while he worked for the Federal Government and used his knowledge to design the first Fairlington Historic District website in 1999. Ron admitted that he learned basic web skills while on the job - "much to the chagrin of my managers since it was not in my job description."

"Having no training in web design, I had to teach myself coding, internet protocols, photography for the net, and a lot more," he said. He didn't have state-of-the-art computer equipment in 1999, so he had to secure and learn software & updated equipment, and continued to do so for the past 20 years...all while serving the community as a volunteer.

Ron retired from the government in 2002, and in 2003 he served as the production manager for the 60th Anniversary Edition of the book "Fairlington at 50: May 1943-May 1993." The original edition was published by Glen resident Catherine Fellows in 1993. For the anniversary issue, Ron and his partner Tom Corbin had to type the complete text from the previous edition because there were no computer files for that first publication.

As you can tell, Ron has been fully committed to the Fairlington Community for quite some time through countless hours of volunteering.

The Fairlington Glen Board of Directors chose to honor Ron with a monetary gift of thanks for his service to the Glen's website.




and new light fixtures, and repairs to front doors as the priorities.

The Board formed the committee in January 2019 and tasked the group with generating ideas for updating/redecorating the common area spaces of the Glen's 23 B Buildings.

Pool Committee Chair Monica Wiedemann reported at the March 12, 2019 Board meeting that her group is already preparing for the upcoming pool season.

The pool hours will be the same as last year, with opening day set for Saturday, May 25 at 10:00am.






A new foosball table and a duck ramp have been purchased for the pool. The duck ramp will be installed by our onsite crew once the pool cover is removed.

Finally, the Fairlington FINS have submitted their annual request to use our pool for the week of July 22. The Board unanimously approved their proposal granting the FINS the use of the lap lane and one additional lane for swim practice Monday-Thursday from 3:30 to 5:30pm that week AND then the entire pool from 6:00 to 7:00pm on Friday of that week for their swim meet.

Patio Trees Are a Co-owner Responsibility



Patio trees, along with other trees throughout the Glen, beautify our neighborhood. They provide shade for humans, homes for birds, and contribute to a healthy environment.

However, please remember that patio trees are the responsibility of the coowner to maintain, including trimming and removal when appropriate. Branches should not touch roofs, gutters, buildings, or interfere with other common elements such as tennis courts. Trunks and roots should not intrude into your neighbor's yard or common elements or even push against fences. If they do, you will be required to remove them at your expense.

When planting new trees in patios, we urge you to consider small trees whose eventual size is scaled for small areas like our patios rather than mighty oaks or maples that are better suited for more open areas. Some trees appropriate for patios include:

Deciduous Magnolia
Star or Gem Magnolia

Eastern Redbud (many color varieties)

Serviceberry

Mountain Laurel (can be grown as small tree)

Crepe Myrtle

Red Spruce

Plum

River Birch

Kousa Dogwood

Bald Cypress

Styrax

Japanese Maple

You Can Help to Save Our Fences

You can help to save our fences by simply **maintaining the interior of your patio fence**. Here are two ways you can make our fences last longer:

- 1. Remove vines from the fences. The Glen does not allow vines on patio fences because they degrade the wood.
- 2. Remove any leaves, dirt, low-lying plants, and debris from the bottom of your fence. This will facilitate drainage and thereby reduce wood rot and slat warping.

The Glen's patio fences will be quite costly and inconvenient to residents to replace, so we need to make them last as long as possible.

It's Tax Time Again



Tax season is here, and if you haven't already filed your federal and/or state tax returns yet, please remember that the deadline to file is April 15 for federal returns and May 1 for Virginia returns.

If you're due a federal refund, you can start checking on the status of your return using the "Where's My Refund?" online tool on www.irs.gov. You can check once per day about 24 hours after the IRS receives your e-filed return or four weeks after mailing a paper return. The tool has a tracker that displays progress through three phases:

1) Return Received, 2) Refund Approved, and 3) Refund Sent. All that is needed to use "Where's My Refund?" is the taxpayer's Social Security number, tax filing status (such as single, married, head of household), and the exact amount of the refund claimed on the return.

"Where's My Refund?" is updated no more than once every 24 hours, and usually that's overnight, so there's no need to check the status more than once per day.

Fairlington Farmers Market Reopens Next Month

The 2019 season of the Fairlington Farmers Market kicks off on Sunday, May 5. Get ready for the fifth season of our neighborhood farmers market offering great foods from new and returning vendors and occasional pop-up vendors.

You can buy fresh produce, grass fed meats, fresh eggs, cheeses, baked goods, flowers, prepared foods, coffee, hot breakfast sandwiches, and more.

The market will be open every Sunday through November 17 from 9:00am to 1:00pm at the rear side of the Fairlington Community Center. Fairlington residents are encouraged to walk to the market.

6th Annual Fairlington 5K Is April 27

Get ready for the 6th Annual Fairlington 5K Run & Walk on **Saturday, April 27**.

This family-friendly event will again be hosted by Abingdon Elementary School and the Fairlington Citizens Association (FCA) to promote health & physical fitness AND to raise money and awareness for Ellie McGinn, a 10-year-old Fairlington Arbor resident who was diagnosed in 2011 with a rare degenerative brain and spinal cord mitochondrial disease for which there is no known cure. The disease slowly robs children of their ability to walk, then stand, and then to coordinate all motor skills.

Participants can take part in the 1K Walk & Fun Run or 5K (3.1 miles) through Fairlington. Part of the 5K course even comes through the Glen. If you can't participate,

perhaps you can help cheer on the runners and walkers.

Registration rates for the 5K will be \$35 for adults, \$20 for kids 6-16, and FREE for children 5 and under. Costs for the 1K Walk & Fun Run are \$15 for adults, \$12 for kids 6-16, and FREE for children 5 and under. Participants will receive t-shirts.

Packet pick up will be Friday, April 26 from 3:00 to 6:00pm at Abingdon Elementary School at 3035 S. Abingdon Street.

Please note that during the event many streets throughout Fairlington will be closed to traffic for up to 60 to 90 minutes. These are rolling road closures, so after the race goes by, that portion of the road will open back up. Road closures begin at 8:00am and, pending delays, should be open by 9:30am. Part of this race comes through the Glen, so plan accordingly!

Proposed Real Estate Property Tax Increase



A public hearing on Arlington County's proposed real estate property tax increase is scheduled for Thursday, April 4 at 7:00pm at the Ellen M. Bozman Government Center, located at 2100 Clarendon Blvd. Arlington County proposes to increase property tax levies.

- **1. Assessment Increase** Total assessed value of real property, excluding additional assessments due to new construction or improvements to property, exceeds last year's total assessed value of real property by 2.7%
- 2. Lowered Rate Necessary To Offset Increased Assessment The tax rate which would levy the same amount of real estate tax as last year, when multiplied by the new total assessed value of real estate with the exclusions mentioned above, would be \$0.967 per \$100 of assessed value. This rate will be known as the "lowered tax rate."
- **3. Effective Rate Increase** Arlington County proposes to adopt a tax rate of \$1.0205 per \$100 of assessed value. The difference between the lowered tax rate and the proposed rate would be \$0.0535 per \$100, or 5.5%. This difference will be known as the "effective tax rate increase." Individual property taxes may, however, increase at a percentage greater than or less than the above percentage.
- **4. Proposed Total Budget Increase** Based on proposed real property tax rate and changes in other revenues, the total budget of Arlington County will exceed last year's budget by 5.4%.
- **5.** The County also proposes to maintain the real estate tax for properties used for or zoned to permit commercial and industrial uses at the current rate of \$0.125 per \$100. Revenue from this tax is dedicated for transportation initiatives.

The County also proposes to maintain the sanitary district tax at the current rate of \$0.013 per \$100 of assessed value. Revenue from this tax is dedicated for the storm water management fund.

Spring Cleaning Reminders

Now that spring is here, it's time to begin our annual rite of spring cleaning. Oh joy!

If you have piles of papers that need to be shredded, please remember that on the first Saturday of every month, Arlington County offers free paper shredding to County residents from 8:00am to 4:30pm at the




Solid Waste Bureau's Earth Products Yard, located at 4300 29th Street South. You may bring up to two boxes or two bags of paper to shred. To learn what types of paper are accepted, visit www.arlingtonva.us and search "paper shredding."

You may want to also conduct a spring clean on your social media accounts. Double check your privacy settings on Facebook, Twitter, Instagram, and Linked-In. Consider deleting photos and updates that you wish to no longer represent you. And perhaps this is a good time to change your passwords.

Arlington E-CARE Spring Recycling Set For May 4

Arlington County's popular biannual Environmental Collection and Recycling Event (E-CARE) is scheduled for Saturday, May 4 from 8:30am to 3:00pm - rain or shine.





Be sure to follow these important guidelines: Bring your ID to verify County residency. Materials will only be accepted during the event's posted hours. Business & commercial wastes will not be accepted. Materials should be in their original containers or properly labeled. Leaking containers should be bagged or boxed to prevent spills. Non-hazardous refuse materials will not be accepted. Smoking is not allowed at the dropoff site.



Arlington County residents can safely dispose of old or expired household hazardous materials (HHM's) such as automotive fluids, batteries, car care products, household cleaners, paint products (25-can limit), lawn & garden chemicals, corrosives, flammable solvents, and propane gas cylinders. Recycle small metal items. Computers, printers, keyboards, scanners, copiers, cellphones, and TV's will be collected. There is a \$15 fee for each computer monitor and a \$20 fee for each TV containing cathode ray tubes - cash or checks only. LED or LCD monitors and TV's can be recycled free of charge. Large wooden console TV's will not be accepted.

Household devices containing mercury, such as thermostats and thermometers, will be collected. Compact fluorescent lights (CFL's) will be collected on site as well.

Acceptable small metal items include pots & pans, tools, Venetian blinds, small appliances, and metal items fitting in an 11.5-inch by 46-inch opening.


Bikes For The World will accept serviceable and repairable bicycles to be sent to countries where they are needed for basic transportation. A \$10 donation per bike is requested to help with shipping costs. They will also accept donations of baseball & soccer equipment AND bike parts & accessories.

Unaccepted materials at this event include smoke detectors, prescription medications, asbestos, Freon, and explosives & ammunition.

Learn More About Mosquitoes & Ticks



With warmer weather ahead, we must now start to think about the return of mosquitoes and ticks. In fact, mosquito season in Northern Virginia typically runs from May 1 to October 31.

With that said, the Fairlington Citizens Association (FCA), the Virginia Cooperative Extension, and the Master Gardeners of Northern Virginia (MGNV) are cosponsoring a presentation on <u>Tuesday, April 9 at 7:00pm</u> at the Fairlington Community Center, 3308 S. Stafford Street, room 118.

Master Gardener Joan McIntyre, who is also MGNV President, will talk about mitigating mosquitoes and ticks in an environmentally safe manner. She will teach you ways to enjoy the outdoors this spring and summer by protecting yourself, your family, and your yard from mosquitoes and ticks without using chemicals.

Street Sweeping Season Is Underway


Arlington County's annual street sweeping season begins this month and continues through October. Street sweeping removes accumulated debris and pollutants, such as sand, salt, metals, petroleum products, and bacteria, before they wash into streams, the Potomac River, and the Chesapeake Bay.

The County estimates that 814 lane miles are swept countywide. The County has divided Arlington's 59 civic associations into 11 street sweeping zones, and Fairlington falls into zone 2. Our next three scheduled street sweeping dates are **April 9**, **May 7**, **and June 11**.

Street sweeping occurs between 7:30am and 3:00pm. Arlington County asks residents who have parked on County streets to move their cars from the streets on street sweeping days so that the street sweepers can provide more effective sweeping.

Arlington Begins Spring Cleaning For Water Pipes

From now through May 6, Arlington's safe and dependable drinking water may taste slightly different as the regional supply system undergoes its annual spring cleaning. Crews at the Washington Aqueduct have begun the temporary disinfectant switch from chloramine to chlorine.



The annual switch is part of a routine program to clean and maintain the drinking water system. During the cleaning, Arlington's Water, Sewer, and Streets Bureau continually monitors the output for safe chlorine levels as well as conducts system-wide flushing to enhance water quality. Running cold tap water for about two minutes, using water filters, and letting water sit in a container in the refrigerator are generally effective for removing chlorine taste and odor.



County Announces 2019 Paving Plans

Arlington County has announced its plans for street paving for 2019, and while no streets in the Glen are affected, several others in Fairlington are.



As you can see in the map to the left, S. Utah Street next to the Fairlington Community Center, identified in red, will be milled, paved, and re-striped this year. And several streets in North Fairlington will be as well.

The County typically mills the top inch and a half to two inches of the existing pavement and then applies a hotmix asphalt to resurface older, deteriorated streets. Their paving program runs from March to mid October.

A notice letter will be mailed to all residents included in the paving project map about four to six weeks in advance of the start of the annual paving operation. Additionally, door hangers will be distributed to affected residents with more specific information 48 hours prior to the paving of their street.
